This year marks TDECU's **65th anniversary**. And when I reflect on what makes this credit union of ours so remarkable, I can't help but see a connection between the organization and our steadfast commitment to our community. The nature of our credit union alone, started by ten employees wanting to lend a hand to a co-worker, truly speaks to what being a Texan is all about. With a mission to provide financial solutions to navigate the journey of life, it's always been about doing the right thing by our colleagues, our friends, our neighbors... the community that surrounds us. And whether you're a TDECU employee or a Member, one thing we can all rally around is improving lives. This has never been more meaningful and more impactful than now.

As I look at the enormity of what 2020 brought into our lives – a pandemic, economic challenges, and uncertainty throughout the country – what I see is an organization ready to make a difference. It's evident in 2019's body of work. Our teams were on the front lines of volunteerism with non-profits in local communities, dedicating more than **6,500 hours** to worthy causes. We provided **\$61,000 in scholarships** to 40 hard-working youth to help further their studies, while ensuring **670 kids** were immersed in

a 5-day STEM experience. We put **163,369 meals** on the tables of the hungry across our markets.



It is thanks to our hard work in 2019 that we are able to move, shift and perform so well as we navigate 2020, and I have a great deal of pride in the generous, unwavering spirit that helped us meet our Members where they needed us the most during these challenging times. We immediately restructured how we do business to be there for our Members while keeping them – and our teams – safe. And we launched customized programs to provide loan payment relief and easy access to cash when it was needed most, including funding over **\$33 million** in Paycheck

Protection Program loans to local businesses to keep them running strong and their employees paid.

We will continue to make a positive impact for change in the days ahead, in that I am confident. Because at TDECU, we're here to help improve the lives of our Members, our employees, and our communities. It's just that simple. Whether it's making our communities brighter, helping families put roofs over their heads, ensuring that hard-working families have the financial resources they need to make higher education a reality, or providing our employees with every opportunity to realize their dreams – large and small – it is our dedication to people-helping-people that makes it happen.

## TREASURER'S REPORT

2019 marked another remarkable year for our Member-owned credit union. We invested in significant resources from a technology and human capital perspective to ensure that year-over-year, we make it easier to do business with TDECU. Throughout their financial journey, our Members can rest assured that TDECU will continue to provide a solid financial foundation with the strength, safety, and security as always.

I am pleased to report in 2019, we saw an increase in assets of over \$340 million, ending the year at \$3.6 billion. We also grew our total capital to over \$317 million - an increase of 9% over the previous year.

In addition to the organization's financial growth, it is also important to note the success of our dedicated Members. In 2019, we returned over \$23.5 million in dividends to our hard-working Members and added over \$320 million in additional deposits. We grew our membership by more than 12.45%, ending the year at 341,195 Members. That's an additional 37,777 new Members gained in 2019 alone!

And finally, one of the most impactful ways we keep our Members connected with their money is through our Member-centric lending programs. In 2019, we funded over \$1.6 billion in loans, providing fair and affordable solutions to help realize dreams like homeownership, living without the burden of high interest rate debt, securing higher education and more. In fact, our student lending program funded over \$4.61 million in student loans that cover gaps where traditional financial aid falls short.

I am so proud of what TDECU is able to do to improve the lives of our Members and I am thankful for the opportunity of membership and to serve as your Treasurer.

# AUDIT COMMITTEE REPORT

The Audit Committee of TDECU acts as your independent representative to ensure the financial condition of the credit union is safe and sound. The Audit Committee is an extension of the Board of Directors and has oversight responsibilities for the financial reporting control process, the system of internal controls, the audit process, monitoring compliance with laws and regulations and monitoring the compliance of operating policies and procedures for TDECU and its Subsidiaries.

Throughout the year, internal audits, external audits and regulatory examinations are performed to carry out these responsibilities in an efficient and prudent manner. The Texas Finance Code requires an annual audit of the financial records of the credit union.

To accomplish this in 2019, the Audit Committee engaged the services of Doeren Mayhew, one of the top accounting firms serving

credit unions in the United States, to audit the financial statements. Doeren Mayhew rendered an unmodified opinion on the consolidated financial statements of TDECU and Subsidiaries for the year ended December 31, 2019.

The Board of Directors' meeting fee was \$750 per Board of Directors' meeting and \$375 per committee meeting.

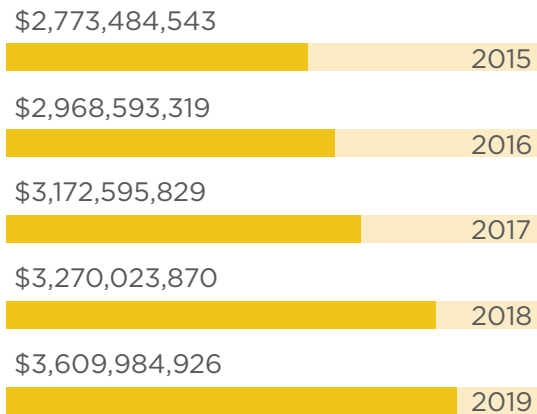

# IN MEMORIAM: THE INSPIRING LUCILLA HENDERSON

When TDECU's Lucilla Henderson passed away in the summer of 2019, she left behind more than a professional legacy of passionate advocacy for the credit union's core values. She left behind a following of admirers who cherished her friendship, her leadership, and her commitment to helping others – including the Members, communities, and teammates of TDECU. As our beloved vice president of community and business engagement, Lucilla Henderson's professional impact was great – yet equally as immense was her personal impact on those who knew her best.

She was always so positive, so caring, and always willing to help. Every time I met with Lucilla, she would start the conversation by asking how my wife and sons were doing, and at the end of all our weekly meetings, she would ask, "Is there anything else I can be doing to help you be successful?" So I always smile when I reflect on Lucilla.

In truth, Lucilla, who joined the TDECU team in 2008, made it her personal mission to help those around her achieve success. It is one reason community engagement was so important to her. Lucilla worked tirelessly to translate TDECU's core community values into actionable programs and meaningful partnerships designed to better both the community and our organization. She appreciated the immense value of relationships and how they can strengthen us individually and collectively, and both personally and professionally. She was an innovator, devising new and creative ways to deliver financial education to our Members and our communities, in the hopes of providing the tools people need to be successful. She was instrumental in developing TDECU's partnership with the University of Houston, which seeks to provide financial resources to a young audience in need of financial education.

TDECU Building and Facilities Manager Dianne Dannhaus, who at one time reported to Lucilla, recalls her as someone who brightened the atmosphere of any room. As they worked together, they forged a bond that Dianne will never forget. "She became my mentor, coffee buddy, but, most importantly, a treasured friend," she says.

"All the talks, prayers, laughs, and tears we shared over coffee will forever remain in my heart. I think of her often and smile as I try to emulate the goodness that was my amazing friend, Lu."

Emulating goodness is something Lucilla did well and inspired in others – especially in her work to help her community. Lucilla was an active community advocate, sponsoring community events – such as the Susan G. Komen Race for the Cure in Houston and the Junior Agricultural Mechanics Show in San Antonio – and volunteering countless hours to worthy causes and organizations each year. She also served the community on various board positions for organizations such as the Brazoria County Association for Children with Handicaps, Junior Achievement, SPCA, and City of Lake Jackson Parks and Development. She was also an active member of St. Michael's Catholic Church Youth Ministry and a dedicated supporter of the Brazosport Chamber of Commerce and Alliance of Brazoria County Economic Development.

When Lucilla was helping in the community, TDECU Compliance Officer Janie Schwartz-Shaw was frequently there by her side. "She often called on me to help out with her various

community activities because she had faith in me,” she recalls. “We played together, prayed together, and leaned on each other for support. She was truly an angel here on Earth, and I was so honored to be her coworker and her friend.”

Lucilla’s hard work attracted attention as much as her kind nature, earning her honors and recognition both within our credit union and within the community. Henderson was recognized for numerous accomplishments throughout her career, including selection to the Brazoria College Board of Regents, Female Executive of the Year from the Houston Hispanic Chamber of Commerce, and as a two-time Paul Harris Fellow with Rotary International, among other honors. A Certified Marketing Director, Lucilla was highly committed to personal and professional development, having earned a Bachelor of Business Administration, followed by certifications in Corporate Citizen Management from the Boston College Center for Corporate Citizenship and in Sales Leadership from the University of Houston Sales Excellence Institute. She was also a member of the Corporate Community Relations Council Houston and the Texas Council Board of the Credit Union Executive Society.

Of her many accomplishments, those Lucilla left behind at TDECU consider her most important one the personal impact she had on others.
